## Practicalities / Praiticiúlach

#### Accommodation

Accommodation will be in the Nox Hotel, Galway for the duration of the event. The hotel's address is: **Liosban Road, Off Headford Road, Galway, Ireland.** The arrival date will be the 5th of March and the departure day will be the 8th of March, so the participation fee covers three nights.

Breakfast is provided by the hotel on the mornings of the 6th, 7th and 8th. We will depart the hotel 30 minutes before the programme begins.

#### Venue

The National University of Ireland, Galway will host the entire event. NUIG is one of Ireland's seven universities and the leading university in the promotion of the Irish language. NUIG Students' Union will help host the event.

#### Travel.

As luck would have it, we were informed on 27/02 that a public transport strike is planned from Monday 6 March for services offered by Bus Éireann. Don't worry.

Galway is a small city, without an international airport. Ireland's infrastructure is Dublin-centric, and it's easiest to arrive in Dublin and travel to Galway from there.

Your student card from your institution will be sufficient to guarantee discounts on most services, with the exception of Bus Eireann services. Please be aware that Bus Eireann services are on indefinite strike as of the first day of the convention so please ensure that you book with other providers.

#### Dublin Airport to Galway direct:

There are a number of private operators running direct services between Dublin Airport and Galway. The journey is 2h 30 mins and the route is scenic. Almost all services offer free WiFi on board and most have toilet facilities. We recommend using the GoBus service (as it is the cheapest), but you may find that the CityLink or AirEagle services are more suitable to your needs.

#### Dublin Airport to Galway via Dublin City Centre:

If ou prefer to travel by train, or you wish to spend some time in Dublin City Centre before travelling to Galway, there are a wide range of services available from Dublin City. Cash fares are accepted on all services but priority is given to passengers with pre-booked tickets.

**Train**: Dublin Bus # 747 travels direct to Heuston Station from Dublin Airport every 10 mins. From Heuston, there a regular Galway (Ceannt Station) service with a journey time of just less than 2h 30. For cheapest fares, purchase an "open return" student ticket at the station, using "student ID number" 12345. See itishrail.ie for more.

**Bus**: GoBus, CityLink, and Bus Eireann operate services from the City Centre. GoBus and CityLink are private providers with central departure points on the quays.

#### GoBus discount: You can access a specific USI discount for the ESC using the code USIMar17. GoBus and CityLink have lower requirements for student ID. All are cheaper when pre-booked in advance.

#### Returning to the airport

The above-named private services run a regular-round-the-clock service to Dublin Airport direct from Galway City Centre. Please allow 20 minutes of walking time from the venue to the bus. The event will close before 12.30 on Wednesday to facilitate timely transport to the airport.

#### Currency & cash

Ireland uses the Euro. Most restaurants and shops accept bank card, but you should be sure to have cash with you just in case. ATM facilities are available throughout Galway city and in NUIG.

#### Taxis

Taxi apps are popular in Ireland, especially Hailo. Taxis not using such technology accept cash only. There is a minimum fare of  $\epsilon_{3.60}$  (or  $\epsilon_{4}$  from 20h to 08h) and a maximum rate of  $\epsilon_{1.10}$  per km (or  $\epsilon_{1.40}$  per km from 20h to 08h).

Taxis in Ireland are safe, regulated and metered - there is no need to agree a fare in advance. Licensed taxis display a yellow plate atop the vehicle.

GoBus gives a comnfortable and quick journey from Dublin Airport and City Centre to Galway. And they've given us a discount. Book it online to get a cheaper fare with the code USIMAR17

## ESU Code of Conduct

#### Preamble

Based on the principles of equality, accessibility and respect, that ESU has given itself and agreed upon by adopting this code of conduct at the Board Meeting 68 in Yerevan, Armenia, the representatives and participants on internal and external events are expected to adhere to the points detailed below. The purpose of this document is to have guidelines that prevent unwanted behavior in the organization and also determine the process to follow up on potential breaches. The participants of each event have to assure that they are aware of the code of conduct and behave according to it.

The EC is responsible for promoting the code of conduct in an appropriate way in the beginning of each event.

#### Participation rules

- Actively engage in the organized activities during seminars, panel sessions and discussions as well attending all the organized sessions, meetings, discussions and debates.

- Respect the timeframes given by the organizers of the event.

- Respect the event's facilities and any rules associated with such use.

- Respect the environment and take care about their surroundings.

#### **General Believes**

-Treat everyone equally irrespective of socio economic background, ethnicity, gender, age, sexual orientation, religious beliefs, political views, reduced mobility, gender expression, disabilities or any other basis of discrimination, abstaining from any direct or indirect discrimination as well from any form of harassment.

- Do not make any inappropriate jokes or remarks, based on any discriminative grounds that cause people to feel uncomfortable or discriminated against.

- Behave and react towards their colleagues with respect.

- Respect the different multicultural backgrounds of their colleagues and reflect on the own behavior.

- Proactively create an inclusive welcoming atmosphere for all of the participants, during both formal and informal parts of the event.

- Do not use demeaning or abusive language towards other participants

We are emphasizing herein that this list is not exhaustive and that the violations of the Ethical

Guidelines might happen outside of the frames given by this Code of Conduct.

#### **Rules of Procedure**

Depending on the gravity of the behavior, the EC in accordance with the ad hoc committee (see below) reserve the right to address the issue in the best way they see fit by applying one

or more of the measures listed below through the set procedure.

#### Active Legitimacy

Any of the participants witnessing the breach or the victim her/himself may report the matter to one of the two persons specifically entrusted to that role for that particular event.

These are designated by the EC for every event and are bound to discretion towards the reported matters. The trusted persons need to be briefed by the equality coordinator before being assigned to be able to handle sensitive situations adequately.

The two persons will be announced at the beginning of the event and should reflect the participants' diversity.

The person informed will immediately forward the information to the ESU Executive Committee and the Equality Coordinator. The person informed will immediately forward the information to the ESU Executive Committee and the Equality Coordinator. However, in case it was not the victim itself reporting the breach, the trusted persons must not forward any information before consulting the perceived victim.

#### The Acting Procedure

Upon receiving the report, the EC has to set up an ad hoc committee balanced with regard to region, gender and other relevant parameters of three to five persons within 24 hours. The ad hoc committee is bound to discretion and obliged to handle the issue brought up with the utmost care.

The ad hoc committee is chosen by the EC including one representative of the EC, the Equality coordinator, and one representative from a member union. The ad hoc committee is chosen by the EC including one representative of the EC, the Equality coordinator and one representative from a member union not involved in the conflict.

At least one member of the ad hoc committee will be of a different gender.

The ad hoc committee will immediately look

into the report, consult the acting parties and bring a decision whether there has been a breach of the Code or not.

If the ad hoc committee decides, there has been a breach of the Code, it will immediately decide upon enacting one of the below proposed measures, on their free estimation of the most appropriate reaction to the breach.

The decision making process within the committee needs to be unanimous.

If the situation requires it, the decision of the ad hoc committee will be read before the beginning of the next session of the event.

#### Measures

- Spoken warning to the perpetrator in question

- Written warning to the perpetrator read before the beginning of the next session of the event in question

- Removal of the perpetrator from the session/ event in question

- Official ESU letter to the sending organization of the perpetrator

- Restriction of participation in future ESU events of the individual breaching the code.

- Allow the injured party (also if no individual was harmed) to make a statement before the next session

Any other measure not mentioned here, in agreement with the Executive Committee. No public action must be taken without the consent of the injured individual or party.

#### Right to Appeal

If the perpetrator (or his/her NUS) in question, or the injured party, feels that the EC decision is wrongly based, whether on fact or principle, they must send in an appeal in writing to the EC or the trusted person within two hours. No action can be taken within that two hour period, unless there is a reason to protect the victim's person. Otherwise the objection has to be presented in writing to the EC or the trusted person within 12 hours.

The EC then decides unanimously to revoke the decision or not or to propose an alternative sanction. If unanimity cannot be reached, the original sanction stays valid.
