Report of the President Tuairisc an Uachtarán Michael Kerrigan

Key Points since last National Council

Policy Book Tracker

I created a google sheets document of all USI policies, their current status, the lead on each policy and a comments section for a description on what has been done.

The Current USI Policy Book has over 400 policies. Since the last National Council, I have met with each policy officer separately to discuss the progress on their policies, priorities for the next 6 months, and discussed what areas of work would not have time to complete in the remaining time. I then met with the regional officers to discuss their mandates, but also to delegate some areas of work from policy officers. The policy book tracker will be an item for discussion at National Council.

TU Bill

USI have been engaging with the Department of Education and Skills on the Technological Universities bill for over 5 years. Not all of our suggestions were taken during those negotiations, so we have submitted several amendments to the Joint Oireachtas Committee and through the Dáíl. We prioritised 3 amendments, the definition of a Students' Union and the number of student representative on Academic Council and Governing Body.

These amendments did not pass, each losing narrowly by 3, 1 and 5 votes. The TU Bill has now passed through the Dáíl and will go to the 2nd stage of the Seanad on Tuesday, January 29th. We are currently rewriting our amendments and will put them through the report stage in the Seanad.

Higher Education Funding

In November, the Minister for Higher Education announced that she would be seeking recommendations from the Oireachtas Committee on the future funding of higher education before Christmas. This has not happened.

The Coalition for Publicly Funded Higher Education will be meeting next week (January 31st) to finalise updates to our policy paper. I have arranged meetings with members of the committee to meet with members of the Coalition over the next couple of weeks. Dates and times have been finalised to meet Tony McLoughlin (FG) Thomas Byrne (FF) Jan O' Sullivan (LAB) Kathleen Funchion (SF) and Lynn Ruane (IND).

Students' Union Autonomy

Following our meeting with officials in the Department of Education and Skill, the Minister referenced out plans on developing a framework for supporting and developing Students' Unions. The VP AA drafted a proposal which was discussed at the Independent SU Committee in December, the proposal will be submitted to the department this week.

Repeal the 8th

I have met with the VP Equality and Citizenship on several occasions to discuss the campaign to repeal the 8th. I have also attended several High Level Group meetings with a number of organisations that we will be campaigning with, these meetings have mostly been about messaging. I also attended the Strike4Repeal gathering that took place outside Leinster House during the debate on the referendum.

USI Office

A significant amount of work has gone in to getting a home for USI. A lot of viewings, Finance Committee Meetings and negotiations took place prior to the extraordinary National Council in NCI. We are currently waiting for information on planning before we can go further with this deal. The majority of my work in this move should now be finished as staff and solicitors will be handling any issues.

USI Congress

The vast majority of USI Congress is organised by steering, however, in the last couple of weeks I have had to ensure that information on submitting motions and USI elections have been circulated. I have also organised a motions collaboration day for February 23rd to ensure that motions submitted are not similar/duplicates to each other, or policies already on the policy book.

Quarterly Review

A second round of quarterly reviews with Officerboard to discuss the performance and achievements over the past 6 months and the plans and priorities for the next 6 months.

Key Points since last National Council

Students for Choice & Repeal the 8th

A significant amount of time, which will be clear with a quick glance through my meetings below, has gone into my work and development of planning, relatonships, and training ahead of referendum.

In brief, USI has supported any referenda SUs have run in relation to stances on 'repeal' or adopting a 'pro-choice' position. One such recent success was with DKITSU. I supported that campus in addressing students and discussing concerns or questions (of which there were little to no dissenting voices) with the VP Border, Midlands and Western Region.

We are developing a suite of trainings in consultation with the USI Students For Choice Taskforce, to include Canvassing training with Amnesty International, Conversations training through and with ARC (Abortion Rights Campaign) and info seminars. The content for these will be applicable to any taskforce to roll out with the assistance of the Regional USI VPs. I have organised also where possible for MOs to interact directly with high quality training. I will contnue to make training as available as possible to all MO teams. We are developing the Students for Choice mailing list further and updates will be much more regular to keep you on track with campaign developments as they happen!

A lot of work has been in advocacy, working with other National Groups to support TDs and Senators. That work very much paid off last week with the contributions seen in Dáil Eireann by TDs across the political spectrum. A system was also developed in-house to make emailing public representatives easier, and I developed a resource called 'Email Your TD' which was made accessible to all MOs until I had the email system ready on the USI website. This system will now be usable for future campaigns on any issue, and the key is making it easy to find your local TD, and be able to make personalised email content rather than mass-mail drafts.

Activist Think-In: A lot of time and work has gone into a mapping exercise of MOs and societies to gather activists so we can have an all-island networking event. I hope this is well attended with at least one sabbatical officer from every SU with a mandate on repeal. This will be crucial for a co-ordinated campaign.

National Council training: It was agreed by USI Taskforce to ensure National Council itself was prioritised for training. Myself and the VP campaigns have agreed to suspend our own working groups in order to ensure a conversation space is created for sabbatical officers at this National Council.

Direct Provision: Action

After a number of weeks planning and discussions with migrant groups, we organised and led an action outside Avoca, to show publicly their links (through owners Aramark) to Direct Provison centres (3) in Ireland, which Aramark very poorly caters and profits from. The action was supported by MASI (Movement of Asylum seekers in Ireland) and ENAR (European Network against Racism) Ireland. Strong MO support came from TCDSU on the day, which was the day before Crhistmas Eve, so we caught peak shopper time. Most shoppers who regularly visited Avoca, didn't know it had been bought out by an american conglomorate.

HEA & Gender Equality

The HEA invited the USI to a stakeholder meeting wth regard to a review of the Gender Equality Report undertaken in and published in 2016. This meeting ended up being a 1:1, with 15 HEA taskforce members (incl. A number of University/IT Presidents, Accenture, and officials from the Department of Education and HEA) and myself.

In a 40 minute interview, I discussed barriers for women's progression in academia, the importance and effect of representation (or lack thereof) of women in various fields or senior academic positions, the issues facing postgrad and PHD students around maternity leave, and implored the committee to seek to include trans and non-binary lenses in their framework, or I told them that the work of the taskforce is updated before it begins.

I attended a second stakeholder event of more than 100 people in The Gresham Hotel, Dublin to further discuss with Human Resources managers and others, the issues of promotion in academia and discussion of systems and approaches that can change them.

#WomenLead18

A lot of time has gone into the planning and organising of this event, which has seen over 60 self-defining women in student register. A double booking of a room left us without a venue for a time, but I managed to secure a suitable space in Smithfield. 18 beds were booked and filled almost immediately, particularly in the week before the event. Beds have been kept for those attending outside Dublin. There is no registration fee.

It's a two day event (an evening and full day) and begins with a networking evening to feature a speaker from the NWCI (National Women's Council of Ireland) and a film with discussion afterwards. The day of training will include basic campaigns training, a panel discussion of experiences from currently elected officers, training in social media use and preparing speeches, some explainer about the work of the campaigns manager, and leadership and self-care. I am really looking forward to a great event.

Disability Seminar

I will be supporting the Vice President for the Border, Midlands and Western region in preparing the content for the disability seminar. The date will be announced asap. We are already in discussion with a number of groups who will be advising and assisting on this important project. It is envisioned that the conference will bring together students who have disabilities across the spectrum of experience at third level, and will offer networking oportunities and to build leadership skills.

LGBTI+: Trans Healthcare and Upcoming Gender Recognition Submission

My work on the LGBTI+ National Youth Strategy continies, and further to that, I have committed to ensuring a national submission to the separate Oireachtas process which is reviewing (independently, through chair Moninne Griffith) the Gender Recognition Act 2015. It is important that submissions are put in regarding this, as in particular our students are affected due to issues from when they were under 18 around their treatment and legal identities, as well as non-binary students who as of yet are not essentially recognised by the state. Joined up subissions are important for this.

USI also supported, attended and I spoke at the recent protest outside Leinster House regarding Trans Healthcare. I sought out advice for my speech as always, conscious of my space as a supportive and active ally regarding this issue. I am still appalled by the utter mystery cloaking access to clear information and guidance around healthcare for trans people in Ireland. If you wish to follow this up further, please contact me.

National Access Plan

I sit on the steering committee for the review and implemnattion of the national access plan, which identifies target areas and groups who require support to ensure entry and success at third level in Ireland. The work on this is ongoing, but as part of the mid-term review of the plan, I will be seeking to put together a panel of students to speak with the consultant writing the report, in particular students from target groups: HEAR/DARE recipients, the travelling community, and mature students. I attended a half day forum along with the Vice President for Welfare and met and spoke with stakeholders in the sector (access and disability officers) regarding the plan and how it can be improved moving forward.

Key Points since last National Council

Education Campaign

The EducationIs...Success Roadshows were scheduled in December, and based on applications we were able to visit two MOs. I was able to attend the Roadshow in GMITSU due to a clash with travel arrangements back from Israel. The clash was entirely my mistake, and I want to apologise to GMITSU for being unable to visit them that day. The VP Campaigns and VP Welfare ran the event on the day. I attended the Roadshow in Bolton Street DITSU later that week with the VP Welfare. Thanks to DITSU and GMITSU for hosting USI!

NStEP Developments

The future of NStEP has been a key focus for a number of months. The proposal paper that I drafted for the expansion of the Programme has been discussed with the NStEP Partners (HEA, QQI, and USI, who meet regularly). The paper was to be revised, as mentioned at NC in IT Sligo, and that revision was submitted in early January. The HEA-QQI Memorandum of Understanding Forum was to discuss the proposal at a meeting on 23rd January, but this was postponed.

I have also taken up membership of NStEP Project Team 1 on 'The Role and Recruitment of Class Representatives', in order to feed in the national perspective from our Member Organisations. I aim to support the work of all 5 Teams if and when I can. All of the NStEP Project Teams are still open for new members. Please let me know if you would be interested.

Further Education and Training

From my last report you will know that I have been working on a proposal paper for engaging and supporting students in Further Education and Training. The Regional Vice Presidents

have also been a great help in mapping out FET in their Regions. I submitted the proposal to the Education and Training Boards Ireland (ETBI) in early January, and I will update as that discussion progresses. A special thanks to Olivia Potter-Hughes and Keelin McGrogan of NUS-USI for their help and advice.

Postgraduate Students

The Postgraduate Representation Network met on January 12th, and there were representatives from 7 Member Organisations. This meeting was incredibly positive and useful to begin mapping out the priorities of any future Postgraduate Campaign, and toward planning for the Postgraduate Voice Symposium.

The 'Postgraduate Voice: A USI Symposium' event is on February 22nd, and I would encourage all Member Organisations to be present and take part in shaping discussions. There is much to be learnt from our postgraduate students. Registration is open on Eventbrite and I cannot stress enough how crucial it is that you promote the event and encourage your students to attend. I am always at the other end of the phone if you need any advice on how best to do this.

National Student Charter and SU Autonomy

In my last report I detailed the meeting that the USI President and myself attended in the Department of Education and Skills. Since then, the Minister for Higher Education has directly referenced those discussions in Dáil Éireann, primarily on developing a Framework for supporting and developing Students' Unions based on the Scottish model. I have since prepared a briefing paper on what this process would look like, and how it links to our aim for a national 'Student Charter'. SU autonomy and the student partnership agenda go hand-in-hand, and the proposed Working Group(s) would examine how best to build that practice in third-level institutions. I will continue to support the work of the USI President in achieving this.

Policy Subgroups of Academic Affairs

Two of the three Subgroups of Academic Affairs Working Group have now met (via video conference). Minutes have been circulated to AAWG with actions to take forward on developing capacity around Student Complaints Procedures and on procedures around Assessment and Feedback. I am now taking forward these actions, although they will require a significant amount of research on practices in our HEIs. My initial focus is on securing a meeting with the Ombudsman Office to discuss work on Student Complaints.

Student Achievement Awards Ireland (SAAI)

The Vice President Campaigns and myself have been tasked with organising this years SAAI. I have been supporting the VP Campaigns on organising the logistics for the event, and I will primarily be focusing on reviewing the Awards categories, the Marking Scheme

from 2017, and the process of nomination and judging. This is almost complete and ready for launch.

International Affairs

I am keen to meet Departmental officials soon to discuss USI's stance on issues of Bologna Implementation and our role in the upcoming Ministerial Conference in Paris.

Mental Health Survey

After reviewing the survey with the PCHEI, the mental health advisory group, the survey was then brought to a professional ethics committee for ethical approval.

The survey consists of various areas including mental health services on and off campus, knowledge of services, and variations of mental health difficulties that students may have faced or currently be facing.

The survey hopes to give us a proper insight into mental health issues that students are currently facing and what seems to be working or not working as the case may be.

We then hope to bring the evidence based data back to students' unions and the HSE which will hope to strengthen lobbying for additional services, and tailoring those services as well as campaigns and local and national initiatives.

Jigsaw Pilot

We are currently working with Jigsaw and have developed a workshop that will be peer facilitated. The two pilot colleges are DIT and IT Blanchardstown. Our Mental Health Project Manager has liaised with welfare officers in both institutions in recruiting suitable students to be trained to roll out the workshop.

The workshop consists of understanding mental health, help seeking behaviour and practical ways in which students can look after their mental health.

The peer training will consist of 3 four hour sessions before the trained peer facilitators can then provide the workshops on campus.

If these are successful we hope to scale up so the workshops can then be rolled out nationally.

Chats for Change

The Chats for Change Roadshow is hitting four campuses from January 29th - February 1st. 20,000 cups and 40,000 student support cards have been disseminated to students' unions across the country to celebrate the 5 year anniversary of the chats for change campaign.

This year we are focusing on what has helped your mental health and the new tagline "Have a chat, make a change" reinforcing the action of talking about our mental health.

The mental health research will also be promoted throughout this week to gain as many responses as possible.

ESU (European Students' Union)

After being appointed to the European Students' Union working group on Mental Health in Higher Education and the Student Movement, we met to discuss how we are to function moving forward.

As a group we aim to collect information from every nation involved in ESU on how mental health initiatives are rolled out in Higher education institutions. We are also looking at mental health attitudes in each Member country and national initiatives that exist in them also, both by the students' unions and government programmes.

I'm very excited to see what other member organisations with ESU are doing in relation to mental health and what we can learn from each other going forward.

To our knowledge this is the first time that information like this has been collected across the nations so we are really eager to collate the information and see what knowledge we can exchange.

SHAG (Sexual Health Awareness and Guidance)

The S.H.A.G week roadshow is taking place from the 12th - 16th February and will be focusing on consent as the overarching theme for the first time.

The consent aspect which is credit to students from Limerick School of Art and Design, gets the message of consent across in clear but fun way. Their Hashtag #GettingIt which has many facets really gets the point across while cleverly playing on words.

The week will have a myriad of information which a focus on a different topic each day. These will include Contraception, STI's, Consent, Crisis Pregnancy and the importance of STI screening and cervical smears.

We will also be launching the the website shag.usi.ie which has lots of interactive information as well as even having video game!

The "johnny's got you covered" street team will also accompany me on the roadshow and has backing from the HSE.

Consent

At present I am collecting data from MO's in relation to consent and what classes have been run in each institution. Gathering of this information will see what methodology is best practice and what will be the best way to proceed in designing consent classes that will go on to be train the trainer modules that can then be replicated across campuses nationally.

After the mental health survey has been run we will be focusing on a reprise of the say something survey which looks at sexual violence and students experience of harassment and unwanted sexual behaviour,.

Drug Testing Kits - Feasibility Study

As I am mandated to look at the feasibility of drug testing kits for the testing of illicit drugs. As part of this I have looked at various organisations such as Students for sensible drug policy, and others in Europe and Internationally who promote the use of drug testing kits.

I have also looked at the process of how drug testing kits work, both home kits and labs who work at night venues and festivals.

In terms of the benefits of using drug testing kits versus not, it has been vital in looking at how the testing process works, the likelihood of their use, and what users will choose to do dependent on the test results.

Students for Choice Campaign

I am going to take this part of my report in 3 sections:

Regional Repeal Group: I have been selected by the VP for Equality and Citizenship, to attend the National Regional Repeal group which will over the next few months look at how all organisations around the country campaigning for repeal can link up together. Once I have a comprehensive list, I will link in the VP for each region with the relevant colleges and organisations. This will be highly important for the campaign over the next few months, as we will be able to work together to run training, and share supports.

Election Training

ESU Gender Mainstreaming policy

As part of my workload on the European Students Union taskforce for 'Women's Participation in the Movement', I took lead on our first task of reviewing ESU's Gender Mainstreaming policy. One of the main recommended changes for the policy, was to use more inclusive language. It has also lead to the identification of another stream of work around the Gender Quotas in ESU elections and working out how to make them more inclusive for trans and non-binary people.

Student Media Network

Working with the VP for the Dublin region and the VP for the BMW region, we have created a database of people working in student media – from journalists to radio presenters and people running podcasts. I have established an online network and I am currently planning a Student Media Networking event to take place in the next month or two.

Students For Choice Campaign

I have been involved with a large body of work around planning for the upcoming referendum on the 8th amendment. I have been working to set up Taskforces on campuses, attended training events, attended the South East Coalition meeting, met with Amnesty to discuss building our own training and attended a couple of repeal planning days.

#EducationIs - County Council motions on Publicly Funded Education (PFE)

The VP for Campaigns and the VP for BMW attended Laois County Council to present on the topic of PFE due to my unavailability. The topic was received well, with almost all Councilors in support. A motion is to be brought forward to their next council for a vote. I am also following up on getting motions passed in Wexford and Cork City as previous presentations have been made there. There a couple of more Councils in the Southern Region that have yet to respond to me but I am still working on securing times to present to those councilors.

Student Councils and local student media

I have been working to provide updates at Class Rep Councils and to provide submissions to student media outlets in order connect more with the wider student community in the South.

Further Education Colleges

I have reached out to all FE colleges in the southern region and I am currently in conversations with four Further Education Colleges about USI membership - Ormond FE College, Kilkenny, Thurles College of FE, Carlow Institute of FE and Waterford Further Education College. The main topic of discussion has been developing constitutions.

The Council were supportive but reluctant to pass a motion until Councillors had more information. The decision was agreed to be taken at the next Council Meeting, where USI were invited back to speak.

Repeal Referendum Preparation

A significant amount of my time has gone into brainstorming, planning and preparing for USI's leadership of the student movement involvement in the upcoming national referendum on repealing the 8th Amendment of the Irish constitution. I, along with the other members of Officer Board will be facilitating canvassing training for students. We have also been working to build a network for student leaders and activist to share knowledge, expertise, ideas and upcoming events, in relation to repealing the 8th Amendment.

Students For Choice

On December 7, 2017, IT Tallaght Students' Union held a referendum for the Union to adopt a Pro-Choice position, in support of the national campaign for full reproductive rights, which includes a woman's right to abortion, whether elective or medically necessary. I coordinated members of USI Officer Board on the campus to campaign for a 'Yes' result in this referendum and was successful with 82% of the voters voting 'Yes'.

Over the past month, I have met with the Vice Presidents for Equality and Citizenship, Campaigns and the regional Vice Presidents to plan, discuss and strategise for the coming months in the lead up to a referendum. There have also been two Taskforce meetings since my last officer report, of which I have attended both.

After delivering training towards the end of 2017 alongside Amnesty International, around the areas of lobbying politicians and talking to them about repealing the 8th Amendment of Bunreacht na hÉireann, I hope to deliver future trainings with a different focus and a shift towards canvassing and speaking to the general public. We are currently creating a document with Amnesty and hope to roll trainings out regionally across the country.

USI Affiliation

IT Tallaght Students' Union held a referendum to determine whether or not their members would remain members of USI alongside the referendum on adopting a pro-choice position. I worked with the VP Campaigns to organise materials for this campaign and coordinated and managed a campaign team which resulted in a 'Yes' win with 98.2% of the total valid poll.

Planning

With it being the beginning of a new semester, USI Officer Board have had day long meetings to strategise and plan for the next six months. Part of this planning was delegating policy from the USI Policy Book to regional Vice Presidents. I have been tasked with several new items to work on and am excited to work on these policies as well as work with Dublin Member Organisations (MOs) over the next semester and prepare for USI Annual Congress.
